## **Originality Checking Scheme for School Assessment Activities**

### **Brief Description of the Scheme**

- The Scheme aims to promote academic integrity in relation to assessment activities through employing a plagiarism detection service to help teachers authenticate the originality of students' assignments (e.g writing tasks, project work etc). The Scheme will make use of the facilities provided by a plagiarism detection service provider designated by our school to help our teachers
  - promote academic integrity;
  - deter plagiarism in students' work;
  - identify potential plagiarism in students' work for prompt remedial action within the school; and
  - supervise their students for work improvement.
- 2. With the implementation of the Scheme, teachers / students send the electronic copy of specified assignments to the designated plagiarism detection service provider (service provider) for originality checking. The service provider will compare the assignments with all the documents stored in its database and the materials available on the Internet and report findings to the teachers / students for follow-up actions.
- 3. Apart from students' assignments, necessary personal particulars including student's e-mail address will be captured by the service provider for identification purpose.
- 4. Our school will select a service provider and inform relevant students and parents/guardians of the name of the service provider in due course. Please be reminded that the service provider may also provide service to other schools that will use the same database to store and check the assignments submitted by other schools.
