<ul style="list-style-type: none"> <li>Detect plagiarism from students' assignments in common digital text format (including Word, Powerpoint, Excel, PDF) presented in English, Traditional Chinese and Simplified Chinese, which will be sampled from / submitted by xxxx students.</li> </ul>	Yes
<ul style="list-style-type: none"> <li>Compare assignments in common digital text format (including Word, Powerpoint, Excel, PDF) presented in Traditional Chinese with the documents kept in the data repository of the service provider or those resources available on the Internet that are presented in Simplified Chinese for the purpose of plagiarism detection and vice versa.</li> </ul>	Yes
<ul style="list-style-type: none"> <li>Storing electronic copies of students' assignments provided by schools from the last x years in its own data repository to facilitate plagiarism detection.</li> </ul>	Yes
<ul style="list-style-type: none"> <li>Upon notification by our school through e-mail or any other means, the service provider should provide to the school all specified assignments stored in its data repository within 7 calendar days.</li> </ul>	Yes
